



Executive Budget Office FY27 Budget Updates

Status of FY27 Budget

- ▶ The [Appropriations Act](#) was ratified by the General Assembly on August 11th
 - ▶ [Part 1A](#) – Funding, Recapitulation, and Statement of Revenues
 - ▶ [Part 1B](#) – Provisos
- ▶ The Governor has submitted 14 vetoes
 - ▶ Agencies with vetoes:
 - ▶ Adjutant General's Office
 - ▶ Department of Education
 - ▶ Department on Aging
 - ▶ Office of Resilience
- ▶ The FY27 budget and vetoes have been loaded into SCEIS

Status of FY27 Budget

- ▶ Part 1A vetoes:
 - ▶ Adjutant General's Office
 - ▶ ***Youth Challenge Program - \$800,000***
- ▶ Part 1B vetoes:
 - ▶ Department of Education
 - ▶ ***Charter School Management Organizations, Charter Authorizer Fees, Charter School Authorizer Contracts, Student Physical Privacy, Assessments and Final Grade Determination, STEM Centers SC, Educator Preparation Provider, High-Dosage Tutoring***
 - ▶ Department on Aging
 - ▶ ***Grant Forgiveness***
 - ▶ Office of Resilience
 - ▶ ***Flood Planning and Warning Solution***
 - ▶ General
 - ▶ ***Scout Motor Site Cost Review, Authorizations for Excess Expenditures***
 - ▶ Statewide Revenue
 - ▶ ***American Rescue Plan Act Reauthorizations***

Allocations & General Increase

- ▶ EBO will finalize disbursements of agency allocations for 2% pay increases and prior year health care annualizations by mid-September
- ▶ Anticipated dates for employees whose general increase is loaded by SCEIS:
 - ▶ **September 16, 2026** paycheck will include retroactive general increase amounts associated with the July, August, and the first September paychecks
 - ▶ **October 1, 2026** paycheck will reflect new semi-monthly salary in regular payroll

General increase amounts from these pay periods will be added to **September 16, 2026** paycheck.

Non-Recurring & Capital Reserve Fund

- ▶ Non-recurring appropriations will be loaded by September 30, 2026
 - ▶ General Fund – Non-recurring
 - ▶ [Proviso 118.21](#)
 - ▶ Capital Reserve Fund (CRF)
 - ▶ [SC H. 5127, Act 261 of 2026](#)
- ▶ EBO analysts will work with agencies on SCEIS loading

FTEs

- ▶ Authorized FTEs will be updated in SCEIS by August 24, 2026
- ▶ FY27 Appropriations Act does not include a mandated FTE deletion process
 - ▶ [FY26 117.193](#)
- ▶ Agencies should continue to ensure that Authorized FTEs = Filled FTEs + Vacant FTEs
 - ▶ [Proviso 117.14](#)
- ▶ [BD-211](#) forms are to be completed by agencies requesting an interim increase in their FTEs

BD-100 and BD-101 Forms

- ▶ [BD-100](#) forms are to be completed by agencies requesting interim authorization increases for Federal funds
- ▶ [BD-101](#) forms are to be completed by agencies requesting interim authorization increases for Other Funds
- ▶ Requests for authorization increases should be related to actual expenditures
 - ▶ [SC Code of Laws Chapter 65, Title 2 \(Federal and Other Funds Oversight Act\)](#)
 - ▶ Please allow EBO adequate time to process these requests
- ▶ These forms are reported quarterly to Senate Finance and House Ways and Means committees
